



## TRANSPORTATION PRODUCTS LIMITED WARRANTY AND LIMITATION OF DAMAGES

### Warranty Terms And Conditions

This Limited Warranty applies **solely and exclusively to the original purchaser only** of new van bodies, trailers or truck bodies that use Stabilit FRP panels (herein called "Panel" or "Panels").

No oral or written representation, information or advice given by Stabilit America, Inc., or any of its representatives shall create a warranty or in any way increase the scope of this express limited warranty and shall not form a part of the basis of the bargain.

**In order to enjoy the legal rights and benefits of this Limited Warranty, you must submit with your claim the original sales receipt upon which appears the name and address of the purchaser, the date of purchase, the complete Panel name, and the lot number of the purchase. Your original sales receipt will be returned to you.**

### What Is Warranted And For How Long:

During the first five years after the date of purchase, Stabilit America, Inc., will repair or provide a replacement Panel or Panels for any Panel that due to defects in materials or workmanship result in rust, rot or water leakage.

### What Is Not Covered By This Limited Warranty:

**By way of example and not limitation, this limited warranty does not cover and Stabilit America, Inc., will not be responsible for and will not pay for:** (a) water leakage caused by accident, abuse, negligence, misuse, riot, fire, or acts of God, (b) water leakage caused by exposing the Panels to a corrosive atmosphere containing chlorine, fluorine, or any other damaging chemicals, (c) water leakage caused by unauthorized use, alteration or repair, (d) water leakage caused by failing to properly maintain or clean the Panels of dirt or debris by using (mild and neutral) soap and water, (f) any expenses incurred for disconnecting or dismantling a Panel or Panels, (g) parts or supplies used in connection with service, maintenance, cleaning, disconnecting, dismantling, fabricating or installing a Panel or Panels, and (i) any increased cost whatsoever related to the failure of or replacement of a Panel or Panels. In addition, if the purchaser discovers or should have discovered a defect in which it is reasonable to conclude that damage, either personal, property or economic, may result, the purchaser's continued use of the product shall constitute an assumption of the risk by the purchaser and a bar to any recovery for breach of this limited warranty.

**REMEDY FOR BREACH OF LIMITED WARRANTY OR NEGLIGENCE: BUYER'S SOLE AND EXCLUSIVE REMEDY FOR ANY BREACH OF THIS LIMITED WARRANTY OR NEGLIGENCE BY STABILIT AMERICA, INC., SHALL BE REPAIR OR REPLACEMENT OF THE DEFECTIVE PANEL.**

Purchaser at all times shall be responsible for any and all travel expenses and freight charges in connection with their repair and replacement of a defective Panel. Stabilit America, Inc., shall have no obligation to repair or replace a defective Panel if purchaser fails to follow the procedure set forth below under the heading "CLAIM PROCEDURE".

ANY IMPLIED WARRANTIES WHICH MAY NOT BE DISCLAIMED BY STATUTE SHALL LAST ONLY FOR THE TERM OF THE EXPRESS LIMITED WARRANTY CONTAINED HEREIN.
